1.0 Preliminaries

1.0 Opening remarks from President Global MEDLAB Week 2022

A Marketing company (Naranhaus) has been contracted to support this initiative. The C-PR has been asked to take over the Global Week activity from now on, including the ongoing, year-long activities. The Global lab week working group will continue as needed to provide direction to this initiative.

New IT partner for IFCC

There have been meetings with multiple companies to find a new IFCC IT company. A request for proposal (RFP) was released and six replies were received. It will be difficult to find one company that will meet all the IFCC needs. At present, Digiwedo from Rotterdam, Netherlands, appears to the best choice. Their strength is in websites and databases and they have a partner that can provide an IFCC smartphone app. There will be additional costs for databases, the app, secure document share/storage for IFCC documents, and the e-Journal and e-News. It is estimated that total cost for new IT provider will be less than current costs.

Rome 2023 EuroMedLab COC and Scientific Program

KA recently attended a COC meeting for the EML Rome 2021 meeting. Concern was expressed that the scientific program is almost entirely European, without sufficient international content and specific IFCC content. The program will be revised to add three new IFCC symposia and one new EFLM symposia. One existing symposium will be relabelled as an IFCC symposia. One or two existing sessions may be relabelled as EFLM symposia. Parallel sessions will be added to accommodate the new symposia. Representatives from IFCC, EFLM and SIBioC will be asked to moderate the Plenary sessions. The plan is for all sessions to be hybrid.

Dubai 2024 WorldLab COC and Scientific Program

This WL location has been approved by the C-CC and a letter has gone to the national society for Saudi Arabia and to the Arab Federation to confirm acceptance of bid. The congress will be held in May 2024. The membership of the COC and Scientific Committee will be determined according to the new IFCC/EML guidelines. The contract with the Dubai conference centre will be finalized soon and an announcement of the congress will be released in May.

The call for bids for 2025 EML will be released in May, and the call for bids for 2026 WL to be released in September.

IFCC General Conference and 70th Anniversary Plans

The EB members should arrive on the Tuesday, October 25, 2022 and the EB will meet on Wednesday and Thursday, October 26 and 27. The functional groups will meet on Friday, October 28 and EB members will join them. The General Conference will be held on Saturday and Sunday, with the 70th anniversary celebrations and special events on Saturday. Past Presidents will may a short 5-10 min presentation. Entertainment (music) will be arranged.-There will be an IVD and an IFCC Scientific panel presentation. The functional group reports will be on Sunday. A QR Code system will be used to monitor delegate participation. MZ will be asked for assistance in implementing this. An organization meeting will be held in May to finalize the agenda and plans.

*IFCC-Chinese Society of Lab Medicine Joint Conference – October 2023 Shanghai*Prof Qing Ming of the US has facilitated initial arrangements for the joint conf on Precision Medicine in October 2023 in Shanghai. Sponsors and Exhibitors will likely be primarily local Chinese/Asia Pacific vendors. Planning is ongoing.

IFCC Virtual Platform

PB will coordinate the training schedule for the InEvent platform for the IFCC Office staff and IT consultant. Training for the EB and other IFCC users will occur later.

IFCC Functional Unit Reviews

KA is reviewing the minutes from the Functional Group review meetings and Action Items will be prepared and communicated to the Division Chairs, with a copy to the appropriate EB Liaisons.

There should be regular review of each functional group and TF once a year. PB will find the form that was used previously for this, and the process will be discussed further.

Initiating an MOU with ICHOM (International Consortium for Health Outcomes Measurement)

Deferred to a future meeting.

Shaping IFCC's Digital Future: A Global Lab Med Digital Education Plan Deferred to a future meeting.

Townhall 2022 for Corporate Members

The GC will be broadcast to all and will be recorded to allow maximum availability. Thus, there is no need for any Townhall meetings in 2022.

Action List from 158th EB Meeting

The Action Items from the 158th EB meeting were reviewed and a revised list will be distributed to EB members.

The funding for EI Microscopio was reduced to \$5,000 USD per year from \$15,000 USD for 2022 and funding will end at that time. Hernan was notified and has responded that he appreciates the funding that has been provided to date. He will survey the COLABIOCLI membership for continued interest in the project and if warranted they will try to get corporate funding for the project. KA will respond to Hernan's letter.

a) New Task Forces:

13.1.17 Task Force on Global Newborn Screening (TF-NBS)

KA has emailed the Chair and there will be a meeting to discuss the TF-NBS schedule for activities.

13.1.18 Task Force on Global Lab Quality (TF-GLQ)

1WA is sending samples to participating countries. Serbia has had some problems with customs but the other shipments are arriving without issue. It was noted that the cost of expanding the project will be greater if labs in new countries are included since additional transportation costs will be incurred. Likely a mix of existing countries and new countries will be included, to a maximum of 100,000 Euros, as budgeted. It was confirmed that the project will be not-for- profit and limited to low-income countries who would not otherwise be able to afford a program, and there should be no concern that the IFCC is competing with commercial providers.

13.1.19 Task Force on Outcome Studies in Lab Med (TF-OSLM)

Call for research grant application

The EB reviewed the proposal from OSLM to call for research grant applications. KA will review the proposal further and a response will be provided to TF-OSLM.

13.1.20 Task Force Global Ref Intervals database (TF-GRID)

Global Reference Interval Database

KA met with the TF-GRID in Munich. The chair, Dr. Jakob Zirk who is an expert in RI is moving the group along very well. They have set up several sub-committees and are designing the first searchable database.

13.1.21 Task Force on Global eLearning/eAcademy (TF-GEL)

IFCC eLearning Accreditation Program

SH has created documents for evaluation of educational presentations that would be eligible for CE. The plan is to start using these forms for the Webinars in September. The next task is to create the certificate provided to attendees with a second page that describes how the sessions documents were reviewed, and which will hopefully support Category 1 CE. It was suggested to contact the European CPAC agency for information on their program and to investigate the ISO 24 standard.

AMLR reported that the translation of webinars to French is waiting for a response from the President of the French speaking organization members.

13.1.6 Task Force Young Scientists (TF-YS)

YS Forum

Update on "Questionnaire on residency training worldwide Lab Med/ Pathology"
The survey on "Residency training" is completed but not yet completely analyzed.
AHA and KA attended YS meeting in Munich. The planning for YS Forum at WL is well along. There are a number of good topics plus a visit to a local laboratory. Some speakers still need to be identified. More YS scholarships have been awarded and some of the funding for those not able to attend will be used to offset additional expenses for some other YSs who need to stay longer. The TF-YS has asked for YS specific awards during the congress. It was suggested that the IFCC could sponsor one award for best oral presentation and one award for the best poster, possibly 200-250 Euros and a plaque. There was some debate on if only YSs should be allowed to attend the YS-Forum but no decision was reached.

International Curriculum

It was noted that there should be an international curriculum for the training/education of Clinical Chemists, to standardize the training and to support the mobility for YSs. The EB has requested the ELFM syllabus (not including the CSLI documents) to provide to the IFCC TF-YS.

YS Visibility

KA feels that the TF-YS could be more active and have greater communication with all IFCC YSs and the entire IFCC family. Regular articles in the eNews is suggested to make more people aware of their activities. A call for nomination for more corresponding members is also recommended.

The TF-YS were asked to support the Global MedLab week on social media and asked to provide videos of their labs for Naranhaus to use in promotions.

Yearly Corporate Members survey results

JP reviewed the results from the Yearly Corporate Members Survey. The Discount on IFCC congresses is a major reason for companies joining the IFCC. Respondents were positive about being associated with the IFCC as a global leader in laboratory medicine, and about being involved with the SD standardization/harmonization activities. The TF-CM is still reviewing information from the survey. There will be discussion on how to respond to the survey findings. The survey will be simplified for the next release. Certificates for corporate member companies and representatives are ready to be sent out with invoices for annual dues. PB will send the final version to KA to review prior to sending them out.

The Munich EML was a very successful meeting, in terms of scientific content, corporate involvement/support, and attendance.

EML 2025 RFP

The call for bids to host EML 2025 will be released in early May.

- 7.3.4.25 Latin American Confederation of Clinical Biochemistry -COLABIOCLI COLABIOCLI León Guanajuato, Mexico, 2022, March 30 April 2, 2022 AMLR and DK attended the congress representing the EB. The congress had 400 delegates and 15 corporate exhibitors, all of whom were required to be tested for COVID and wear masks at the meeting. A number of awards were presented at the opening ceremony: three by COLABIOCLI, two by the Mexican College and one award by Wiener. There were three IFCC VLP presentations, 2 COLABIOCLI VLP presentations and 60 poster presentations. Young scientist scholarships included 5 from IFCC, 2 from COLABIOCLI and 2 from Roche. An additional 50 scholarships were granted by the University and 30 by industry.
