1.0 Opening remarks from President

IFCC General Conference and 70th Anniversary Plans

The program for the General Conference in Brussels is being finalized and will be distributed soon. The meeting will be a hybrid meeting. KA, AHA, PB and Patrizia were in Brussels recently to finalize the venue. Approximately 30 functional groups are expected to meet there, each for ½ day except for the SD which will meet for a full day. The GC is a closed meeting for IFCC functional group members, National Society representatives and other invited guests only. A survey will be sent out to the National Societies to identify issues they would like to be considered at the conference.

Global MEDLAB Week 2022

KA met with C-PR in Munich and asked them to take over the Global MEDLAB Week project, starting with Seoul. Rajiv has committed that the committee will be active and will promote Global MEDLAB Week at all congresses in the future. C-PR plans to create one minute videos from prominent IFCC individuals, and a magazine is being prepared for the GC. Rajiv is also suggesting a contest, but no details are available as yet.

Website Redevelopment - New IT partner for IFCC

DIGIWEDO has been working on the new website. There is a homepage draft that is being revised based on some initial input. The new proposal is coming out soon and KA will share with the EB for comments. Other website pages look good.

Dubai 2024 WorldLab COC and Scientific Congress Committee

The COC and SPC membership is being finalized. KA will circulate a list of proposed members based on the revised IFCC Congress Guidelines, for EB comment and approval. The final committee membership will be posted on the congress website, www.Dubai2024. KA and Sergio met with the Dubai Affiliate Society President, who agreed to join the COC. KA will recommend to the SPC that there be a symposium from the Dubai Society at the congress. The COC will meet in Dubai in first week of Dec.

IFCC-Chinese Society of Lab Medicine Joint Conference – October 2023 Shanghai This is still on hold due to COVID-related travel restrictions and if the planning cannot begin soon it may have to be delayed to 2024.

IFCC Virtual Platform

Training on InEvent started on April 27, 2022 and is ongoing. The InEvent platform will be used for the GC in Brussels, including the EB meeting for those who attend virtually. The functional groups may use InEvent or Zoom, if they have not been trained on InEvent.

IFCC-JCTLM-ICHCLR Relationship

KA met with BIPM, JCTLM and ICHCLR representatives in Paris at the BIPM offices. One outcome was agreement that the Chair for SD Chair will sit on the JCTLM board. KA will make full report on the meeting at the GC.

IFCC Conference Guidelines: WorldLab and EuroMedLab
KA will provide additional recommendations for changes to the IFCC Conference
Guidelines at the next meeting.

IFCC Taskforce on Environmental Impact of Lab Medicine

DK has prepared a draft description and objectives for this new Taskforce. KA will review and it will be shared with the EB for review.

New initiative on development of IFCC Practice Guidelines in Lab Medicine CSLI documents are not used in many developing countries. There is a need for simple, short guideline documents that can be used by developing countries. The IFCC could take the lead on this, working through existing committees. The TF-COVID recommendations are a good example. This would also promote the IFCC as a significant leader in this area. A formal process would need to be developed regarding the drafting, vetting, publishing, etc. Perhaps IFCC could also provide a summary or resource for guidelines that currently exist (focusing on laboratory implementation/algorithm/reporting model). The EB was supportive of this idea. This matter will be discussed further in Brussels.
